# Broxbourne Sports Club Terms and Conditions of Membership

## **MEMBERSHIP**

- 1. This agreement commences once the member has read and agreed to the below Terms and Conditions and once payment has been received.
- 2. Your membership starts on the Payment Date agreed by both parties and expires on the Renewal Date. Your membership cannot be cancelled during this period irrespective of a change to your personal circumstance.
- 3. Every member who pays the £5 charge will be provided with a fob which gives access to the clubhouse and must be used to obtain discounts on bar purchases. The fob is solely for the named member's own use and must not be used by anyone else.
- 4. The membership is not transferable and must only be used by the registered member. Any misuse of membership will result in the membership being cancelled.
- 5. The management committee of Broxbourne Sports Club (BSC) reserve the right to cancel any membership in breach of rules or conduct which in the view of the management of BSC is offensive to members and/or staff or represents a health and safety danger.
- 6. Membership entitles a member to full use of the club facilities during opening hours associated with the type of membership they have undertaken.
- 7. All junior members under the age of 12 must be accompanied and associated by a club coach, an adult member or parent/carer. The associated adult is wholly responsible for the juniors' health, safety and wellbeing whilst present at BSC.
- 8. Members may bring guests to the club, but are responsible for ensuring that all guests are aware of the Club's rules of conduct.

## **FEES AND CHARGES**

- 1. The membership fee due for the type of membership undertaken is payable upon the start of this agreement.
- 2. BSC review the pricing of membership on an annual basis and you will be notified of any changes to your membership amount in writing at least 30 days in advance.

## **GENERAL TERMS**

- 1. You agree to advise BSC immediately of any change to your Personal Details. This can be done by updating your account details online.
- 2. Your personal details are held in a secure system and will be used by the club to keep you informed about club activities that you may be interested in.
- 3. You agree to comply with the rules of membership which are displayed on the club's website.
- 4. We may terminate this agreement with immediate effect on notice to you if you are in breach of the Club's rules.

#### **FACILITIES AND SERVICES**

- 1. We reserve the right to close the club or areas of the club from time to time at our discretion. E.g. for maintenance repairs, refurbishment, cleaning, local emergencies and bank and public holiday periods
- 2. Opening hours are subject to change by giving advance notice where reasonably practicable.
- 3. Members wishing to use squash and tennis courts must adhere to the relevant procedures. Squash and tennis courts must be booked and paid for at the published rate for the time of day/type of membership. Please refer to the club website for further guidance.

## LIMITATION OF LIABILITY

- 1. Members must both secure their personal belongings on their person or secure them in the lockers provided by BSC at all times whilst using the club's facilities. BSC, our employees, agents or sub contractors will not be liable to you for any loss, damage or theft of any property brought onto any of our premises.
- 2. You are responsible for ensuring that you correctly operate or use any facilities and/or equipment and we do not accept responsibility for any harm or injury to you while using them unless caused by our employees, agents, sub contractors or our negligent act or omission.
- 3. Coaches operate in our club on a self employed basis. Any service they provide to you constitutes a contract between the Coach and you rather than us. BSC accept no responsibility for breach of contract or negligence caused by a Coach.
- 4. In accepting these terms and conditions, parents/guardians of junior members are giving permission for their children to participate in the activities provided by the section(s) they are joining.
- 5. Parents/guardians are responsible for informing the club about any special care needs, dietary requirements, allergies or medical conditions that could affect his/her safety at the club.

#### CONDUCT

- 1. You will treat other members, guests, staff, coaches, referees and anyone else using the facilities with respect at all times. Offensive behaviour and bad language will not be tolerated.
- 2. You will not abuse the facilities or equipment at BSC and you will pay for any damage to our property where you or your guests wilfully or negligently cause such damage.
- 3. Appropriate sports clothing and shoes must be worn at all times when participating in sports activities at the club. Footwear must be appropriate for the playing surface.
- 4. Dogs are permitted in the grounds of the club, but must be kept on a lead at all times and their mess picked up.

### **MISCELLANEOUS**

- 1. We reserve the right to take photographs of our facilities (which may include you, provided your inclusion is incidental) for press and promotional purposes provided we give reasonable notice.
- 2. Our failure to enforce any of our rights at any time, for any period and for whatever reason will not be constructed as a waiver of such rights; neither will any failure to identify or act upon your breach of the terms of this contract be deemed to be an affirmation by us that your behaviour is acceptable.
