# THE GREEN PLAYING SURFACES

The constant work throughout the season has paid dividends with cricket only being curtailed due to inclement weather. Although this year has been exceptionally dry, which has posed its own issues. All playing surfaces have been superb with compliments from all visitors. The three tennis courts we have, are, as always been kept in excellent condition and are again being utilised for Wimbledon qualifiers.

Earlier this year, with funding from the ECB (England and Wales Cricket Board) allowed the installation of three hybrid cricket pitches (strips) which allows more cricket to be played with less degradation of the surface. Bearing in mind the amount of cricket we have, (men's, ladies, juniors and country games) it has been a game changer.

# HARD PLAYING SURFACES

Constant cleaning leaves and brushing keeps the AstroTurf and the Tennis and Padel courts in the best conditions. This also includes mould treatment around the edges.

We acknowledge there is an issue with courts 6, 7, 8 with tree roots. We are awaiting a reply from our insurers before invoking repairs.

#### **TREES**

We have many trees with protection orders (tpo's) that we have to maintain. We constantly keep trees in safe order. This is an expensive task but is essential.

#### RECYCLING

The recycling regime which has been implemented is turning out to be successful to an extent.

#### **EQUIPMENT**

An extensive amount of machinery is required to service the 12.5 acres, much of which is very old, and a programme of replacement is necessary over the coming years.

## **CARPARK**

Constant repair s to the carpark is unfortunately a necessity. We acknowledge that funds are being sourced to provide a permanent solution- at which time we want to improve the security of the carpark which we know is essential.

# **HEALTH AND SAFETY**

Very important for all our staff due to be nature of the work is to be properly trained and the staff now carry EMSS (safety course) passports.

The engagement and subsequent on-going training of Harry, our apprentice groundsman is an ongoing success story.
