Appendix 1.

Broxbourne Sports Club – restructure update

The club held an Extraordinary General Meeting in April 2024. Thanks to the unanimous support of the members who attended, it was agreed that the club would change its structure. This means closing the current CASC, Community Amateur Sports Club and transferring all the club's assets to Broxbourne Sports Club – a company limited by guarantee, which is also registered as a charity.

In order to satisfy charity regulations, we have also had to register a separate company Broxbourne SC Ltd – this is a wholly owned subsidiary of Broxbourne Sports Club and will operate the bar and other trading activities. All profits will be reinvested into the charity.

There were 2 main reasons for making this change:

- The trustees, a company called Zedra, wanted to retire from their role and by forming a legal entity i.e. the company it has enabled the transfer of the land.
- The club was at risk of breaking HMRC's rules for a CASC due to the amount of non-member income

The property legal transfer was eventually completed 7 months ago, though we are awaiting the formal registration of the title at HM Land Registry.

Unfortunately, it has taken much longer than planned to begin trading under the new structure. The main reasons for this were delays in setting up our new VAT and banking arrangements. We were intending to go live on 1st December, however due to further issues with VAT and the banks, we have now decided to delay until 1st April 2026.

Members should notice minimal change as far as the day-to-day activities of the club are concerned. As a company limited by guarantee, members' maximum individual liability is just £1. However, there will be key changes behind the scenes. Most importantly our finances will come under greater scrutiny as our accounts will be submitted to Companies House and the Charity Commission. This means that all transactions will have to be properly recorded, no cash payments for goods and services, etc. The Directors will be issuing guidance on our new financial procedures in the next few weeks.

Alongside this we are reviewing how the board and the various committees will function – Gary will be outlining this for you shortly.

All this means that we will need to involve more members as volunteers to help everything run smoothly and effectively. Two specific areas where we need more help are:

- Finance – we would like to hear from anyone with relevant experience who can support Mike and Rosie
- House – we need to establish a house committee to manage the maintenance and development of the main clubhouse and the tennis pavilion.
